enthusiast and a very active guy. He's also a huge fan of South Muskoka Hospital.

"A group of us were ATV trail riding at night just outside of Gravenhurst and I was the last rider, ensuring everyone was safe. Unfortunately, I became the one who needed help. My ATV flipped over and landed on top of me. I was out cold. When my friends noticed I wasn't behind them, they raced back for me and quickly called an ambulance."

Ben woke up briefly in the ambulance en route to South Muskoka Emergency. He was worried he wouldn't be okay, that he'd bleed out before he could get care. The opposite happened.

"The ambulance ride was short, and the emergency team at South Muskoka was ready. I remember them saying, 'We've got you, Ben.' And they did exactly that. Their expert care not only positioned me for recovery shortterm, they also did everything in their power to ensure I'd be okay long-term."

Benjamin Devlin believes in South Muskoka Hospital. They weren't just there for the emergency - they were there to ensure he got the best care long-term.

### Keeping an eye on multiple patients from one place

South Muskoka Hospital requires a completely new and upgraded Central Patient Monitoring System. The system means entirely new software, accessories, clinical training and physical hardware including central stations, patient monitors and a telemetry system. The \$1 million dollar multi-year investment will significantly improve patient care in both the ICU and the Emergency department at South Muskoka Hospital.

The cutting edge technology will enable staff to better monitor and manage patients across critical care and inpatient units; which means reducing staff burden when the hospital faces staff shortages. The upgraded technology will also support future expansions and growth opportunities as we plan for the new South Muskoka Hospital.



"The new monitoring system will have a significantly positive impact on patient care. A modern system provides more accurate and faster detection of arrhythmias and other cardiac abnormalities. The new technology is designed to improve clinical workflow, reduce errors, support faster decision making, and ultimately provide better, safer care for patients. The modern system supports our hospital's mission of delivering high quality, evidence-based care."

and support when they cottage. That includes not thinking about local healthcare.

"I didn't know much about South Muskoka Hospital; I didn't think I'd ever need it while I'm here at my cottage in Port Sandfield. I found out how wrong I was one day when I developed appendicitis during COVID. I got to the hospital in short order and was surprised at what I discovered."

Geoff was amazed and impressed by the skill and compassion of the emergency team and surgeons at South Muskoka. He was also thrilled about how quickly he received care.

"I know people in Toronto who have similar urgent issues and end up waiting much longer for care and treatment. The skills of my doctors and nurses here were very good and would be comparable to resources in the city... and much more accessible. I now know how important this hospital is to my summer home and I think it's important other cottagers believe that too. We all need to support our hospital here."


